**COMBINED NOTICE OF (1) CONFIRMATION OF THE JOINT
LIQUIDATION PLAN OF AUTOMOTIVE PROFESSIONALS, INC., AS
MODIFIED, AND (2) ADMINISTRATIVE EXPENSE CLAIMS BAR DATE**

1. **Entry of the Confirmation Order.** An order (the “Confirmation Order”) confirming the Joint Liquidation Plan Of Automotive Professionals, Inc., as Modified (the “Plan”), filed by Frances Gecker (the “Trustee”), Chapter 11 trustee of Automotive Professionals, Inc. (“API”) and the Official Committee of Unsecured creditors of API (the “Committee”), was entered on March 26, 2010 in the above-captioned bankruptcy case (the “Case”).

2. **Administrative Expense Claims Bar Date.**

- a. **Administrative Expense Claims.** All creditors other than Professionals asserting Administrative Expense Claims shall file with the Bankruptcy Court and serve on the Trustee and the Committee an application for allowance and payment of an Administrative Expense Claim no later than May 28, 2010 (the “Administrative Claims Bar Date”).
- b. **Professional Fee Claims.** Final fee applications by all professionals requesting compensation or reimbursement of expenses for services rendered during the Case, shall be filed with the Bankruptcy Court and served on the Trustee and the Committee on or before the Administrative Claims Bar Date. Objections to final fee applications shall be filed no later than June 28, 2010.

3. **Status Report and Hearing.** The Trustee will file a written report of the status of initial payments required and made, separately stated for each class treated under the Plan, by June 22, 2010. A hearing to consider the status report is set on **June 29, 2010, at 10:30 a.m.**, in Courtroom 742, Everett McKinley Dirksen United States Courthouse, 219 South Dearborn Street, Chicago, Illinois.
